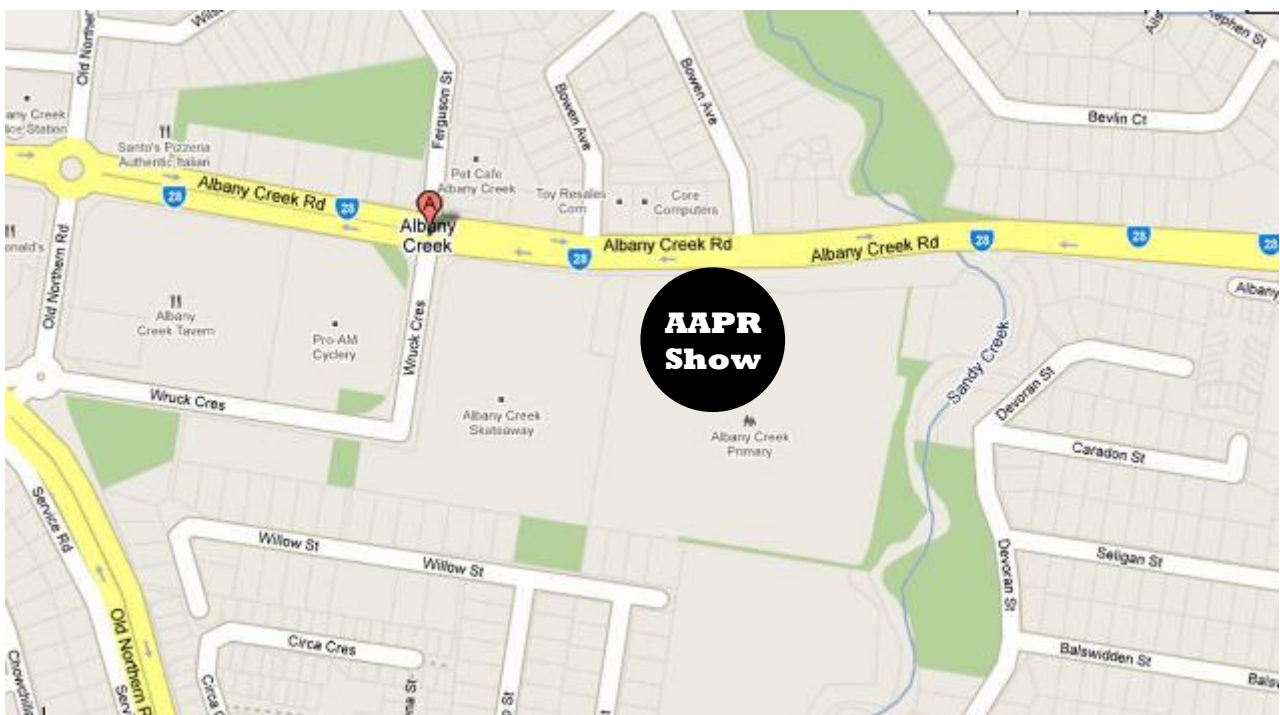

Art Competition Terms & Conditions of Entry

In signing and submitting this entry form the Artist enters into an agreement with the Arts Alliance of Pine Rivers Inc. (hereafter referred to as "the Organisers") and agrees to comply with all of the following terms and conditions.

All completed Entry Forms must be in the hands of the Organisers no later than Friday August 13, 2010. No late entries will be accepted.

1. Paintings, drawings, photographs, sculptures and pottery in any medium are acceptable for entry. All work must be the original and unaided work of the artist and must not breach any copyright laws.
2. **Entry of art work includes free admittance for the artist plus partner to the opening night function.**
3. All work must be for sale. The Organisers will deduct 25% commission on all sales. Artists will be paid within 14 days of the closure of the Exhibition.
4. Entry fees are non-refundable.
Artwork less than 1 square metre -
\$20.00 for first entry, \$12.00 for every other entry.
Artwork greater than 1 square metre -
\$22.00 for first entry, \$14.00 for every other entry.
Photography categories -
\$16.00 for first entry, \$8 for every other entry.
Any artwork which exceeds 1.4m on any side will be subject to negotiation.
AAPR members will be entitled to two free entries after payment of the first entry.
5. All work must be suitable for hanging, correctly marked and labelled on the back with **labels that will be supplied** to accepted exhibitors, and be ready for hanging with strong wire (flush not protruding) or other professionally approved methods. If the above conditions are not met, entries may not be exhibited.
6. The Organisers will not meet delivery charges on return of any entries.
7. The Organisers will display selected entries at the Albany Creek Primary School, Albany Creek.
The Official Opening times will be:
Opening Night: Fri 27th August 6.30pm - 9.00pm
Sat 28th August 9.00am - 5.00pm
Sun 29th August 10.00am - 3.00pm
8. The Artist appoints the Organisers as his or her agents for all purposes associated with the exhibition and agrees to allow the Organisers to offer all entries for sale to the public at the price stated by the Artist on the entry form.

9. All entries entered will be considered for judging. Each entry is only eligible to win one award category.

10. ALL ENTRIES MUST BE DELIVERED TO THE ALBANY CREEK PRIMARY SCHOOL ON Thursday 26th August BETWEEN 1.00pm & 6.00pm.

11. Unsold entries must be collected from the Albany Creek Primary School on Sunday 27th August from 3pm to 5pm. No responsibility will be taken for uncollected entries, which will be forfeited one month after the date of the Exhibition.
12. Please retain your receipt as proof of ownership when collecting entries.
13. The Organisers' and Judges' decisions are final.
14. The Judges reserve the right to withhold an award selection in any category if all entries are deemed to be unsuitable.
15. The Organisers reserve the right to select which entries will be displayed during the exhibition. No refunds will be given for entries not displayed during the exhibition. The organisers further reserve the right to withdraw any work at any time from the Exhibition.
16. The Organisers will exercise all reasonable care in handling the works submitted, but will not be responsible for the loss of or any damage to any works while in the custody of the Organisers. Insurance against damage, fire and theft on individual works whilst in the Organisers' custody or in transit is the Artist's responsibility.
17. The Organisers shall have the right to photograph work and publish those photographs for publicity purposes.
18. Artists must complete the GST declaration on the entry form. Any applicable GST on the sale of a entry is the Artist's responsibility. All marked prices are to be inclusive of any GST where applicable. Prizes won by Professional Artists who are registered for GST will include the applicable GST amount in addition to the published competition prize amount.
19. If an entry that has been submitted on the Entry Form has been sold by the Artist prior to the exhibition, a substitute entry may be entered in its place. No penalty or additional fee will apply.
20. All awards are non-acquisitive unless otherwise stated.
